ocial Security System (SSS) President and Chief Executive Officer Rolando Ledesma Macasaet today urged Filipino workers to be vigilant and regularly check if their contribution records are updated as the SSS pursued delinquent employers nationwide.

Macasaet led the simultaneous Run After Contribution Evaders (RACE) operation, which called on more than 1,200 emplovers nationwide to settle their contribution delinquencies, amounting to over P335 million and affecting the social security coverage of nearly 19,000 employ-

"Our members can now easily check if their SSS contribution record is updated using the My.SSS Portal, which they can access through their smartphones. If they find out that their employers

are not remitting their contributions, we advise them to report it immediately to our SSS Branch Office to investigate," Macasaet said. In a RACE operation held in Ouezon City, Macasaet emphasized that employers should religiously remit their workers' contributions so they will not deprive their employees of SSS benefits.

Macasaet said that if their contribution records are not updated, they will not be entitled to claim SSS benefits or apply for loan programs.

#### CLINICAL TRIALS IN THE PHILIPPINES

I am looking for an expert who could help me understand how clinical trials are being conducted in the Philippines, or how they ought to be conducted. I took an interest in this matter when I heard from some sources that some clinical trials are being conducted either by the Food and Drug Administration (FDA), or by the DOH. I then took the trouble to send queries to both the FDA and the DOH, but so far, I have not received their replies. I am curious what their reply would be, because I really think that there would be a conflict of interest in doing the tests, if the outcome of the tests could potentially favor a private company of any kind. We should still wait for the reply of both the FDA and the DOH before we judge them, but in the meantime, I suggest that these two agencies should instead enable the private sector to conduct their own tests, especially those small companies that have limited funds for product development. Since the FDA has a regulatory function, I think that it may not be able to go into product development. That role might be more appropriate for the DOH but only as an enabler or policy maker. The DOH could also choose to fund the research of nonprofit companies, in which case there would be no conflicts of

#### LOCALIZING FIRE PROTECTION

I think that the Philippines might be one of the few countries in the world wherein the fire services are nationalized or federalized, instead of being localized. Why is that so? I recall that the reason why police services were nationalized was because the local politicians supposedly took advantage of their positions to use the policemen for their own private armies. That supposed problem does not affect firemen, to be sure. To be clear, I am not against the idea of retaining the PNP as the national police, because it could even co-exist with local police departments, in the same way that the old Philippine Constabulary (PC) co-existed with local police departments at that time. Having said that. I do not see the need for a nationalized Bureau of Fire Protection (BFP) that will co-exist with local fire departments. It is ironic that while the government is talking about devolution of functions to the LGUs, no one seems to be talking about devolving fire services. It is time I think that the devolution of fire services should already start, because fire protection is really a local concern. It is disappointing to note that up to now, there are still some LGUs that do not have fire trucks, and even if they do, these are already too old to be useful. This problem could be avoided if the fire services were devolved.

#### STUNTING AND MALNUTRITION

Obviously, there is a symbiotic relationship between stunting and malnutrition. To be clear, malnutrition does not necessarily result in stunting. In theory, stunting affects only infants and younger children who are malnourished, or are extremely malnourished, in other words. Also in theory, juveniles and adults are no longer prone to stunting. It is important to know the difference between stunting and malnutrition, and to know the difference between infants and adults, so that we can isolate what the problem really is. When the problem could be isolated. then the government would know how much money to allocate, to provide nutrition, that is the only solution to stunting. How can life be fair if the growth of children is stunted starting from their infancy? How can these children even compete with other children in the schools, when they have a serious handicap in the first place? Since we know that most of these children are born out of poverty, we could almost be sure that they have no other way to go but down to even deeper poverty. As soon as possible, the government should create a database of stunted children, so that we will know who they are, where they are, and how many there are. Right away, the LGUs should be mobilized to solve this problem right away at the local level.

#### SOLID LINES AND TRAFFIC RULES

What could be the reason why drivers do not obey traffic rules? Is it because they are ignorant of these rules? Or is it because they simply choose to ignore these rules? As far as I am concerned, it could be a combination of these two reasons. But first, let me take you back to where the process of issuing driver's licenses should start. As of now, the present process starts with a written exam that would supposedly test the applicant's knowledge of the traffic rules. However, we all know that these exams are not entirely secure, such that anyone could pass these if they get a little help from some fixers. I think that the correct beginning of the process should be driver education, such that the applicants will be taught first about traffic rules, before they could take the tests that will measure how much they have learned about the lessons that were taught to them. "For example, an SSS member was hospitalized for ten days due to an illness. Suppose their employer is not remitting the SSS contributions. In that case, they will be unqualified to receive sickness benefits from SSS because one of the requirements of the said benefit is to have recency in contributions," he

He emphasized the importance

of an up-to-date contribution record, as the monthly contributions of SSS members serve as the basis for qualifying for SSS benefits.

Meanwhile, Macasaet issued a stern warning to delinquent employers, making it clear that SSS will not hesitate to file charges against them, adding, "Non-remittance of SSS premiums is a criminal offense that violates Republic Act No. 11199."

Under the law, SSS Executive Vice President for Branch Operations Sector Voltaire P. Agas explained that employers who fail to register their employees or have not deducted and remitted their contributions to SSS will be penalized with a fine of P5,000 to P20,000 and face imprisonment ranging from six years and one day to 12 years.

"Employers who received the violation notices are given 15 days to

coordinate with their respective servicing SSS Branch Office and settle their contribution delinquencies, and if they fail to act on it, SSS will take legal action against them," Agas said.

Meanwhile, Macasaet said the nationwide crackdown against delinquent employers on Tuesday aimed to show SSS' solidarity with Filipino workers and recognize their significant contribution to commemorating Labor Day.

# SILAKBO 2024 ng Santa Rosa, muling tagumpay na naisagawa



The 2023 CPBI will collect and generate information on the levels, structure, performance and trends of economic activities of the formal and informal sectors of the economy for the year 2023. Also, it will serve as benchmark information in the measurement and comparison of the national, regional and provincial economic growth, while the 2023 IOSPBI will provide a the 2023 I-O Table of the Philippines. It will collect detailed data on revenue, cost and inventories in businesses and industries of the country belonging to the formal sector of the economy for the year 2023. These data are needed to build an input structure and to construct a distribution of output for the 2023 I-O Table.

The total number of samples of Laguna for the 2023 CPBI and 2023 IOSPBI is 2,677 and 802, respectively. Samples were selected according to Total Employwill be covered on certainty or 100% basis while those with TE of less than 20

will be taken on a sampling basis.

To augment the operation, PSA-Laguna will hire Statistical Researchers aside from selected PSA Laguna staff who will be involved in the operation.
