DA gives aid to El-Niño stricken farmers in Calabarzon

he Department of Agriculture (DA) in CALABARZON has tapped into the Rice Competitiveness Enhance Fund (RCEF) to provide financial aid amounting to P5,000.00 to each farmer affected by the El Niño phenomenon.

Suzette Claribelle Panopio, senior agriculturist in DA IV-A, stated that the agriculture department has also positioned P8.308,964.50 worth of farming interventions in the region under its flagship crop programs.

Under its Rice Program, the DA has readied 4,508 bags of inhred certified seeds reportedly valued at over P3.4 million.

Department of Agriculture's RCEF Seed Program delivers certified inbred seeds to help farmers from Regions IV-A and IV-B prepare for the 2024 dry season.

Meanwhile, the Corn Program has allocated P2.4 million for interventions in insecticides and rodenticides, and an estimated P2.5 million worth of interventions have been prepared under the High-Value Crops Development Program.

Panopio said: "We have positioned agricultural interventions that can be distributed as soon as rainfall increases. Since there is no current rainfall, we cannot distribute the seeds yet. We are advising





Calabarzon's April 2024 inflation rate recorded at 3.6%

LIPA CITY, Batangas – The Philippine Statistics Authority (PSA) CAL-ABARZON announced the April 2024 inflation in CALABARZON via hybrid press conference on 15 May 2024.

Regional Director Charito C. Armonia reported that the prices of commodities in the region increased by 3.6 percent. This increment is lower than the increase in March 2024 which stood at 3.7 percent.

Lower increment in prices for Housing, Water, Electricity, Gas and Other Fuels commodity group compared to the previous month's rate contributed to the deceleration in the overall inflation rate (IR). The average price increase was recorded at 1.9 percent in April 2024, from 2.4 percent in March 2024.

Also, contributing to the decrease in inflation were the lower increase of prices of Restaurants and Accommodation Services and Alcoholic Beverages and Tobacco commodity groups which were recorded at 7.4 and 3.9 percent in April 2024,

from 8.3 and 5.7 percent in March 2024, respectively.

Likewise, lower increase in prices of commodities were also recorded in three provinces in April 2024.

Batangas posted an IR of 3.6 percent, from 4.7 percent in March; Cavite at 2.7 percent, from 3.1 percent in March; and Rizal at 5.4 percent, from 5.5 percent in March.

On the other hand, higher increase in prices of commodities were posted in Quezon province at 2.3 percent to 4.5 percent in April and City of Lucena from 2.9 percent to 4.5 percent in April.

Laguna recorded the same inflation rate compared to March 2024 at 2.8 percent.

The PSA will continue to closely monitor regional Inflation patterns throughout the year, providing monthly reports to the public. For more information and inquiries on the results, visit https://rsso04a.psa.gov.ph.

farmers to consider crops more suitable for the current weather conditions as an alternative to rice."

DA CALABARZON and its attached agencies, including the National Irrigation Administration, converge their efforts to train their respective Disaster Risk Reduction and Management personnel. Their goal is to develop a system for faster assistance to local government units and introduce modern agricultural technology to

farming communities

"We are encouraging them [farmers] to adopt [modern] farming methods and technology to help them conserve water. We are also introducing rotational water distribution strategies where we need to only add fertilizers, instead of harvesting the crops," Panopio explained.

The senior agriculturist mentioned that the DA implemented a rotational water distribution strategy to ensure that farmlands receive an adequate water supply despite the extreme weather conditions.

The agriculture department has also utilized protected agriculture technologies to regulate the temperature and mitigate the impact of excessive heat in farmers' nurseries and greenhouses.

In addition to their groundwork, Panopio added that DA CAL-ABARZON is keeping the public informed by utilizing their media platforms for an information advocacy drive on the effects of the El Niño phenomenon.

According to the department's April 25 report, El Niño has resulted in approximately Php131,997,476.54 in agriculture production losses throughout the region.

Rice farmers bore the brunt of the months-long below-normal rainfall, with approximately 2,671 farmers and fisherfolk reporting harvest losses due to the prolonged extreme heat.

trust and transparency in its relationship with the residents of the areas where it operates.

APRI, for instance, gave updates on its ongoing project, Tiwi Binary Plant, which is expected to generate an additional 17 megawatt for the Luzon grid. To ensure that the voices of

Preparing young learners to become topnotch mathematicians and writers seems to be the key mission of Crisanto Guysayco Memorial Elementary School as their learners rose to top the academic math and writers.

ing challenges — both national and international — clearly showing the effectiveness of

their numeracy and literacy programs.

In the recently concluded 4th Math-INIC Vedic Mathematics National Challenge, students from CGMES showcased their mathematical prowess, securing the top spots. There are six (6) categories in the competition which are: Beginners: 9 years or younger (born after Nov 30, 2014); Primary: 11 years or younger (born after Nov 30, 2012); Juniors: 13 years or younger (born after Nov 30, 2010).
