COOPERATIVE OWNED TOLL ROADS

Can you imagine how much of a nightmare the flow of traffic would have been, if not for the toll roads built by the private sector under the Build-Operate-Transfer (B-O-T) scheme? To be honest, I would have preferred not to have privately owned toll roads. I say that because if not for graft and corruption, the government would have more than enough funds to build roads without any need for private investors. To put it another way, it is as if we are being taxed again when we pay the toll fees, despite having paid our taxes already. When it comes to farm to market roads however, we have been waiting for too long already, and it is now time to try something new. Therefore, if the B-O-T scheme is the only way to build these local roads, then let it be. However, I would add the condition that the proponents should be local, so that the local economy would benefit, instead of the big conglomerates from Imperial Manila. On that note, the contracts should be given to the local cooperatives. There are new technologies now, such as a non-toxic soil stabilizer that is available Reynolds Soil Technologies. It could be used by local coops to build local toll roads that could last longer than cement and asphalt roads, and yet cost cheaper. As proof of concept, there are actual project sites that could already be visited.

HELPING INDIGENOUS CULTURAL MINORITIES

The law requires municipalities, cities and provinces to appoint representatives of Indigenous Cultural Minorities (ICMs) to the municipal, city and provincial councils if there are enough of them who are living within their jurisdictions. This is a wonderful provision in the law, but it seems that its implementation is not uniformly or consistently done all over the country. At the outset, I would say that the Department of Interior and Local Government (DILG) and the National Commission for Indigenous Peoples (NCIP) are the agencies that should take the lead in implementing these laws, but it seems difficult to gather compliance data about which jurisdictions are abiding with the laws and which ones are not. Aside from the two NGAs and the three levels of LGUs, I believe that the role of NGOs in the overall implementation should also be recognized, including the many Churches Based Organizations (CBOs) that are helping the ICMs everywhere. Counting everyone, there should be a three-way cooperation in this overall process. Where can we get information about the status of implementation? And how can we find out about the progress of the cooperation? Can any of the NGAs, LGUs and CBOs bring out the information? Ideally, there should be an office for ICM affairs in the LGUs.

(PDRRMO) holds Basic Life Support (BLS) and Standard First Aid trainings for personnel, as well as volunteer workers of LGUs, district hospitals, and private agencies in the province; regular participation in national earthquake and fire drills; and regular holding of bloodletting activities.

Furthermore, the provincial government issued Executive Order No. 12, s. 2023, titled "Creation of the Provincial Core Group and Technical Working Group for the Formulation of the Enhanced Local Climate Change Action Plan (ELCCAP) of the Province of Laguna. The Laguna Climate Change Adaptation and Mitigation Office (LCCAMO) has started implementing such order in alignment with its "goal of establishing a climate-resilient province equipped with an updated and scientifically-based Local Climate Change Action Plan."

LCCAMO also collaborated with Laguna University and Laguna State Polytechnic University, holding consultative meetings with different LGUs in the province to assess the necessity of implementing Greenhouse Gases Inventory (GHGI) as an essential element of ELCCAP. Such sessions are held to formulate a solid foundation for promoting ecological awareness and resilience among the people.

Not to mention the significant contribution of Barangay Volunteer Workers (BVWs) in conducting regular clean up drives in barangay roads, waterways, rivers, and the lakeshore; weeding and caring for trees seedlings; tree planting activities; and proper solid waste management, among others. Their commitment in protecting the environment from the adverse effects of climate change is truly remarkable.

The most recent is the groundbreaking ceremony for the construction of the first ever DOHrun tertiary hospital, the Laguna General Hospital, in Brgy. Puypuy, Bay, Laguna on 16 May 2024. This was made possible through 2nd District Representative Ruth M. Hernandez's persistent lobbying of House Bill # 9623, approved during the Senate hearing held on 02 April 2024.

In theory, cooperatives could own and operate any business under the sun, provided that it is legal. Given that premise, it is therefore perfectly doable and allowable for a cooperative to own and operate a health clinic, even a hospital, for that matter. Since there are no legal impediments towards doing that, the coops should go towards that direction, and they should get help if they want to do that. It's no big secret that the existing Rural Health Units (RHUs) are almost always ill-equipped, short-funded and are lacking in doctors, nurses and other related health professionals. As a matter of fact, you will be lucky if you can find a doctor in an RHU, more so in the Geographically Isolated and Depressed Areas (GIDAs), as defined by DOH. As part of my advocacy, I am now convincing some satellite based internet service providers (ISPs) to look for possible uses of their services that would have a social impact in remote areas, as part of their Corporate Social Responsibility (CSR) programs. Also, as part of my advocacy. I have invited Dr. Luis Ramon Rodriguez, President of Philippine Medical Depot (PMD), to make his "Healthy Me" all-in-one kiosk innovation available to coops under affordable terms. Hopefully, with the combination of these ISPs and PMD, more coops could put up their own health clinics.

The curriculum is a key factor in defining the caliber and efficacy of the teaching and learning process in education. It provides teachers with an outline by defining the fundamental concepts, abilities, and moral principles that children must learn. Teaching Elementary Pupils Effective Literacy Skills

Learning to read, write, speak, and listen is crucial for young children starting school. They serve as, in many respects, the cornerstone for pupils' future academic achievement in every topic. Thus, the role of an elementary school teacher in fostering early literacy skills is critical as this will lay the foundation for long-term academic success.

Teaching elementary learners effective literacy skills is a multifaceted process that involves several key components. Thus, elementary educators must be proficient in implementing evidence-based instructional methods to ensure learners to develop the necessary language skills. For instance, the emphasis on teaching learners systematic and explicit phonics instruction, along with opportunities for repeated practice is crucial to building strong neural pathways in reading. This would eventually lead to learners' proficiency in decoding words, learning to read words accurately and quickly, and language comprehension.

Moreover, it is imperative that teachers provide students with ample opportunities to engage with authentic texts, build vocabulary, and develop comprehension strategies. This process requires a structured and comprehensive approach to reading and writing instruction. Here, young learners are given guidance and support to read various genres, such as fiction, non-fiction, and poetry, and produce written works for different purposes and audiences. Additionally, learners must be explicitly taught critical thinking skills to engage with complex texts and articulate their ideas effectively. Critical thinking skills should be integrated across various subject areas to foster deep understanding and application of content and knowledge. Elementary language teachers must provide their learners with texts that challenge them to analyze, evaluate, and synthesize information from diverse sources. This will enable learners to build a solid foundation in critical literacy skills and become thoughtful, engaged citizens.

Utilization of technology in teaching language skills in elementary classrooms can also be highly beneficial. As we are dealing with 21st century learners, the integration of digital tools and resources can enhance learners' motivation, engagement, and language development. For example, the use of interactive whiteboards, educational apps, and online reading and writing platforms can reinforce key literacy concepts and provide immediate feedback. Furthermore, technology-based instruction can offer personalized learning experiences tailored individual students' learning needs and styles. The only setback with technology is that it may not be accessible to all learners, requiring educators to thoughtfully consider its implementation.

Nevertheless, the success of early literacy instruction in elementary schools' hinges on the teachers' ability to employ a balanced, comprehensive, and research-based approach that addresses the diverse need of all learners. Effective language arts programs should be designed to develop strong foundational skills in reading and writing, while also nurturing the critical thinking and communication abilities that are essential for academic and personal success of every learner.
