Last April 12, 2024, the San Pablo Colleges' BA Communication students (MASKOM Society), headed by their Director, Ms. Marielle Hular alongside her team of officers and members of the Communication program, in collaboration with the City Information Office, conducted the first-ever film festival in San Pablo City, Laguna: The Sine Usisa San Pablo Film Festival (SUSPCFF). It was held at the Multipurpose Convention Center located at Barangay San Jose. The program for the awarding ceremony was embarked on by the Dean of the College of Arts and Sciences of San Pablo Colleges, Prof. Natalia Nizel S. Briñas through her opening remarks. It was followed by an inspirational message from Mr. Enrico Galicia of the Citv Information Office. The judges for the film festival were then introduced, and the film showing for the last screening had started. After the three entries were shown, a feature film from San Pablo Colleges' BA Communication (MASKOM Society) entitled "Bakit Mainit Ang Huling Patak ng Kandila?" under the Malik-Mata Production was showcased. The film tells a tragic story about poverty, drugs, and child labor.

After the viewing of MASKOM Society's feature film, it was time for the award. "Gunita" won third place, "Slaughter Smiles" for second place, and "Ayyy AI!" bested among the three entries. The latter won best screenplay. James Kian Don (Director for Slaughter Smiles) won Best Director. Under the same production (Prodigies Production), "Slaughter Smiles" also garnered several awards: Best Musical Score, Best Film Poster, Best Cinematography, and San Pableños People Choice Award.

The event marked the beginning, of an opportunity for student filmmakers and for those aspiring to be in the film industry to fill in creativity, a heart and soul, with utmost dedication, in producing works of art not just for the sake of only producing, but rather, a calling that shall be embraced to transform life messages into films. As for the origin of Sine Usisa, it was developed to see societal issues through the lens of filmmaking using creating stories, narratives, and truth-provoking perspectives and ideas. Indeed, SUSPCFF fulfilled the hearts of those who desire the industry of film, and those who dream of understanding life through films. A beginning, a legacy that goes on.

Engage in activities that bring you joy and fulfillment. This could include

spending time with loved ones, pursuing hobbies, or participating in community events. In Filipino culture, activities that reinforce social bonds can be particularly healing.



He said the rehabilitation of the portion of Maharlika Highway within their jurisdiction, which spans 231 kilometers from Calamba City to Tagkawayan in Quezon, is being pursued by the administration. The DPWH official did not specify the target completion date of the highway rehabilitation project but called it "a top priority."

Mendoza also underscored the significance of the South Luzon Expressway TR4, a 48-kilometer bypass road from Santo Tomas in Batangas to Lucena City, Quezon, which is envisioned to alleviate congestion in San Pablo City.

This ongoing infrastructure project is intended to significantly reduce travel time in the region from four hours to one hour, making it a more convenient alternative to the congested Daang Maharlika.

Barring any unforeseen delays, the road is expected to be partially passable by 2025.

In Cavite, Mendoza said the 40-kilometer East Lateral Road from Aguinaldo Highway to Nasugbu, Batangas, once completed, will ease traffic in Tagaytay City, particularly on weekends when tourist traffic peaks.

Additionally, the flyover in Mendez town, Cavite, is expected to alleviate congestion at the Mendez junction leading to Nasugbu, Batangas

Mendoza also highlighted the construction of a 1.42-kilometer bridge linking Lopez in the mainland to Perez in Alabat Island, providing a faster alternative to boat or barge travel.

"This locally funded project enhances connectivity to remote areas," Mendoza said.

The K to 12 program was designed to improve the basic education system in the Philippines and align it with international standards. The program aimed to strengthen the curriculum and extend the number of years of basic education from ten to twelve. K to 12 was introduced and implemented starting in 2016 at the grade one level, comprising seven subjects: English, Math, Mother Tongue, Filipino, Araling Panlipunan, and MAPEH.





EUWENN MIKAELL ALETA WINS FAMAS BEST CHILD ACTOR FOR 'FIREFLY'

Abstract:

The performance of teachers should always be a top priority and it is one of those that need to endure and enhance even in times of crises. Due to COVID-19 pandemic, various additional curricular and non- curricular ancillary teachers perform as part of their duties and responsibilities. This study determined the relationship of non-curricular ancillaries and the performance of public school teachers in Tanay, Rizal. A descriptive-correlational research design was used in 147 teacher participants coming from different schools in Tanay. Gpower software was utilized in determining the sample size while stratified random sampling was applied in the selection of participants. Questionnaire-checklist on responsibility and accountability on noncurricular ancillaries were administered as research instruments. The data was

investigated using descriptive statistics and correlation analysis. The findings revealed that in terms on their non-curricular ancillaries the public-school teachers in Tanay were completely accountable and responsible. It also showed that the teachers have a very satisfactory performance. Correlation analysis showed that there is no significant relationship on the non-curricular ancillaries and performance of public-school teachers. This implies that the teachers can perform well even though they have additional task in schools like printing and sorting and distribution of modules, cleaning and disinfection of classroom, and managing classroom communication beyond teaching hours. Added to these are Feeding Program coordinator, Gulayan sa Tahanan Coordinator and activities assuring that mental health of students are well due to health crisis brought by COVID-19 which are considered non- curricular ancillaries.
