Inclusion of "Bagong Pilipinas Hymn And Pledge" to the Government Agencies Flag Raising Ceremonies

The office of the President announced Memorandum Circular No. 52, series of 2024, which directs government agencies to include the recital of "Bagong Pilipinas Hymn and Pledge" during flag raising and flag lowering ceremonies. This aims to instill the principles of Bagong Pilipinas brand of leadership and governance among the government workers, according to Malacañang. The memorandum was signed last June 4, 2024, but was published on public last Sunday, June 9, 2024.

Malacañang directed all the heads of all national government agencies, as well as the government-owned and control corporations and educational institutions, to ensure the Bagong Pilipinas Hymn and Pledge were properly disseminated. The Presidential Communications Office (PCO) was also tasked to implement measures to communicate and make available of the said hymn and pledge to all government agencies and pub-

However, there are still institutions and agencies that were in doubt of the said Circular. According to Teachers Dignity Coalition (TDC), they find this move impractical and unnecessary. It also reminiscent of the political propaganda tactics seen during Martial Law years.

"True nationalism and patriotism cannot be enforced through hollow rituals or the blind worship of national symbols, let alone a piece of propaganda," TDC said.

Senate Minority Leader Aquilino "Koko" Pimentel III said that a law must cover the singing and recitation of Bagong Pilipinas Hymn and Pledge. He explained that a simple executive directive is insufficient. Furthermore, he suggested that they must first submit a bill containing those ideas to amend the existing laws governing the National Anthem, Pledge and Flag Raising Ceremonies.

In contrary, Senate President Francis "Chiz" Escudero said that he is not in contrary with the released Memorandum Circular. There is nothing wrong in singing and reciting the terms of hope, helping one another, and aspiring for progress, he added. He also explained if they really want it to be included, the right way is to amend the Flag and Heradic Code and In July 2023, President Ferdinand Marcos Jr. ordered national government

agencies to adopt his administration's governance slogan "Bagong Pilipinas" in their programs and projects.

According to Memorandum Circular 24, Bagong Pilipinas "calls for deep and fundamental transformations in all sectors of society and government, and fosters the State's commitment towards the attainment of comprehensive policy reforms and full economic recovery."

The memorandum also said the governance slogan is "characterized by a principled, accountable and dependable government."

Upshot of Tiered Task Instruction in Teaching 4th Grade Science Concept

Being flexible and able to offer multiple channels of information has become increasingly important in teaching Science concepts effectively, especially for learners of varying academic abilities. The upshot of tiered task instruction can provide a framework to address this need. Science learning is essential for all students at all grade levels, and instruction should be designed to maximize student engagement and academic achievement regardless of their prior knowledge or proficiency levels. Tiered Task Instruction is an instructional strategy that could help achieve this objective.

In utilizing this type of instruction, the teacher must involve providing young learners with multiple entry points to access and engage with course content and demonstrate their understanding. They are divided into groups according to their skill levels, and lessons are then customized for each group. In order to meet the demands of each group, different levels of assignments and products are used to implement tailored education.

All students should find tiered lessons adequately demanding, according to the goal. Higher skill levels do not lead to boredom, and lower skill levels do not lead to frustration. This approach allows teachers to differentiate learning experiences based on students' readiness levels, interests, and learning profiles. Thus, Tiered Task Instruction can be a powerful tool to meet the diverse needs of all learners in a science classroom

As 4th grade Science teachers, one must design learning experi-

ences that foster critical thinking, problem-solving and hands on exploration of real-world phenomena. When students are working on tiered tasks, they can engage in these higher-order skills at their own levels. This can help develop and strengthen their understanding of core science concepts and principles.

In strategizing tiered instruction to support students in learning science, teachers must consider how to scaffold learning through the use of carious resources, tools, and instructional approaches. The key in this situation is to adjust the activity's focus according to whether each group is prepared for more complex work or is just beginning to understand the idea. Task selection is a critical aspect of this, as teachers must carefully choose activities that are appropriately challenging.

Activities like making posters about a certain topic—recycling and environmental protection, for example while the other group may build a model about habitats or ecosystems, can provide an engaging, differentiated learning environment. This allows learners to demonstrate their understanding in ways that re meaningful and accessible to them.

Similar to difficulty, activity tiering based on differentiated outcome allows all of your students to use the same resources, but the results will vary based on their preparation levels. Although it might seem odd at first, advanced students can benefit greatly from using this technique to work on more complex applications of their knowledge and skills.

Research indicates that when Tiered Task Instruction is implemented effectively, it can lead to significant academic gains for all students. The result is a classroom where differentiation is carefully considered to ensure that all learners can maximize their learning experience in Science which not only increase their engagement, but also cultivates their critical thinking and problem solving skills.

This is particularly important for learners who come from disadvantaged backgrounds or have experienced trauma, as they may require additional resources and interventions to address their unique needs.

Third, a risk-aware child protection policy can help schools identify and address the underlying factors that may contribute to poor academic performance. By monitoring indicators of risk, such as attendance patterns, behavioral issues, or changes in academic achievement, schools can implement targeted interventions to support struggling learners and prevent further escalation of problems.

Nevertheless, it's important to note that the relationship between child protection policy and academic performance is complex and multifaceted. Successful implementation of child protection measures requires collaboration between educators, social workers, families, and the broader community.

Effects of Catch-Up Fridays on Teachers and Learners

Catch-Up Fridays -- an educational initiative by the Department of Education Secretary and Vice President of the Philippines Sara Z. Duterte -- aimed at providing students with additional instructional time specifically allocated for re $mediation, enrichment, and \, collaborative \, learning \, opportunities \, within \, the \, weekly \,$ school schedule, have garnered significant attention.

Focusing on reading, peace education, values lessons, and other skill-building exercises, these designated Fridays present a unique opportunity to present content and activities that may not fit seamlessly into the standard curriculum while also offering teachers the flexibility to address learning gaps in the mentioned areas. However, the implementation and effectiveness of Catch-Up Fridays have been subject to extensive debate, with proponents highlighting the potential benefits for both teachers and learners, along with the drawbacks highlighted by critics.

From the perspective of teachers, Catch-Up Fridays can serve a dual purpose, allowing them to provide targeted support to struggling students, while also affording them the chance to explore more creative and enriching instructional approaches in teaching reading not typically feasible within the confines of the core curriculum. This time allocation presents the prospect of addressing individual student needs more effectively, fostering personalized learning experiences.

Additionally, the collaborative nature of Catch-Up Fridays encourages a more interdisciplinary approach, where teachers can work collectively to identify and address common learning gaps, share best practices, and develop innovative strategies. They enable educators to take a more holistic view of student development, moving beyond the traditional academic metrics.

Yet, the implementation of Catch-Up Fridays is not without its challenges. One noted drawback is the lack of materials and resources specifically tailored for these sessions, potentially leading to inconsistent or suboptimal learning experiences for students. Another concern raised by critics is the potential for Catch-Up Fridays to be viewed as an 'add-on' or 'extra' rather than an integral component of the educational framework, potentially diminishing their perceived value and undermine its intended impact.

The effect of this initiative in our learners is equally complex. This dedicated time can provide much-needed respite from the rigors of the standard curriculum, fostering a sense of engagement and enthusiasm through hands-on activities and collaborative learning opportunities that would lead to improved reading outcomes.

However, as Catch-Up Fridays is not graded for assessment purposes, some students may view them as less critical, potentially leading to decreased motivation or engagement. Additionally, the diverse range of activities and the lack of standardization in implementation may result in inconsistent learning experiences, potentially exacerbating existing achievement gaps if not properly addressed.

While the potential benefits of this approach are well-documented, recent studies have uncovered nuanced insights into its impact on both teachers and learners. Ultimately, the success of Catch-Up Fridays hinges on the careful curation of resources, the alignment with broader educational goals, and the effective integration into the overall school schedule and culture, ensuring that this initiative lives up to its promise.

The Enigmatic Rise of Mayor Alice Guo: Bamban's Beacon or a Beacon of Controversy?

In the heart of Tarlac, a province known for its sugarcane fields and brave revolutionaries, the small town of Bamban has recently found itself in the national spotlight. At the center of this attention is Mayor Alice Leal Guo, a figure shrouded in mystery and intrigue.
