GOV. ARAGONES CALLS FOR REMOVAL OF ELECTRIC POLES OBSTRUCTING ROADS IN LAGUNA

SANTA CRUZ, Laguna — Governor Sol Aragones has directed MERALCO, the Department of Public Works and Highways (DPWH), and local government units (LGUs) to immediately address the issue of electric poles obstructing roadways and causing heavy traffic in several parts of the province.

During her inspection in the town of Los Baños, Gov. Sol personally observed electric poles positioned along an entire third lane of the road.

According to her, this is one of the reasons behind the slow traffic flow in the area, especially since Los Baños is among the most traffic-congested towns in Laguna due to its narrow roads.

"Motorists should not be inconvenienced just because of these poles. There must be better coordination between the DPWH and LGUs before implementing road-widening projects to avoid this kind of situation," the governor stated.

Gov. Aragones further emphasized that smooth traffic flow is not just a matter of convenience but a vital component of effective public service and economic development in the province.

With the cooperation of the Los Baños LGU, led by Mayor Niel Nocon, along with MERALCO and the DPWH, efforts to resolve the issue were immediately initiated.

Over 50 poles are set to be removed from the roads and relocated to proper areas.

Desmos in Pinoy Math

In today's fast-changing classrooms, especially when it comes to math, digital tools are no longer a luxury—they're becoming a real necessity. For many Filipino students who see math as something to fear, technology might just be the helping hand they need. One tool that's been making a noticeable difference is Desmos, a free online graphing calculator that turns cold numbers into something students can actually see, move, and make sense of.

Desmos helps bring abstract math to life. Instead of solving problems mechanically on paper, students can now explore how equations behave visually. Over at desmos.com, both learners and teachers can play with graphs, patterns, and even animations that make complicated topics easier to understand. It shifts learning from memorization to meaningful understanding.

In my classes at ISUFST, Desmos has truly changed the game. Subjects like calculus, trigonometry, analytic geometry, and statistics—often the ones students dread—suddenly feel more approachable. I've seen students' eyes light up when they slide a variable and instantly see how the graph reacts. Those moments of clarity, those "aha!" sparks, happen more often with Desmos than with traditional board work.

There's research to back this up. A study in the Eurasia Journal of Mathematics, Science, and Technology Education found that students who used Desmos performed better in understanding functions than those using traditional methods. For a country like the Philippines, where we often struggle in international assessments like PISA and TIMSS, that's a bright spot worth noting. Desmos helps students not only catch up but understand why the math works in the first place.

What I love about Desmos is how it encourages experimentation. Students get to play around—try equations, make mistakes, and learn from them right away. It turns math into a puzzle they want to solve, instead of a chore they have to finish. It builds a growth mindset, helping them realize that making mistakes is part of learning, not a reason to stop trying.

Teachers benefit as well. Desmos offers real-time insights into how students think. It helps us ask better questions, guide discussions, and create a classroom culture that values understanding over just getting the right answer. Because it promotes collaborative learning without putting anyone on the spot, it works well with our Filipino value of pakikisama—harmonious learning, together.

Of course, like any tool, Desmos works best when used thoughtfully. I always start small, beginning with simple graphs before layering in more complex ideas. That way, students build confidence step by step. Combine this with open-ended questions, and suddenly the classroom is full of curiosity and conversation.

What really excites me is how Desmos connects math to everyday life. Want to figure out the arc of a basketball shot? Desmos. Want to design a dream house using lines and slopes? Go for it. Math stops being just academic and starts becoming personal and practical.

But we can't ignore the hurdles. Desmos is free, but not all students have access to gadgets or stable internet. That's where we need serious support—better infrastructure, more training, and policies that prioritize digital learning. Every student deserves a shot at tools that can help them succeed.

No, Desmos isn't a silver bullet. Some lessons will still need textbooks, guidance, and plenty of support. But it lays a strong foundation. It helps students understand the "why" behind the math, something rote memorization just can't do.

As we look to the future of math education in the Philippines, we need to think bigger and bolder. Desmos is just one piece of the puzzle, but it's a powerful one. It helps shift the conversation from fear to curiosity, from memorizing to truly understanding. And that shift can make all the difference.

With tools like Desmos, we're not just teaching math. We're helping students see its beauty, its logic, and its real-life power. And maybe, just maybe, we're helping them fall in love with learning again.

CLASSES WITHOUT CLASSROOMS

EDITORIAL

It is shocking and heart-wrenching: a government office with barely a dozen in a high-tech air-conditioned boardroom, just blocks from a public school where students sit elbow-to-elbow, some writing on laps, others pinched next to the door—or worse, learning from a shade tree. This is not unusual. It is a daily routine for thousands of students suffering from the country's acute classroom crisis.

DepEd pinpoints the shortage as over 165,000 classes. The elementary schools suffer worst, accounting for nearly two-thirds of shortage. Places like CALABARZON, NCR, and Central Luzon are among those with incidents of highest overcrowding. In some cases, rooms which only accommodate 45 today have between 80 and 90 students. Over 8,000 students move in shifts at Misamis Oriental General Comprehensive High School in rooms which never experience a break.

This is not a matter of space only. This is a matter of safety, health, and dignity. Overcrowding leads to poor ventilation, less attention, and high-stress levels. Salawu et al.'s study (2023) confirms that congestion diminishes both pupil achievement and teacher performance. With busy schedules and crowded, airless rooms, even dedicated teachers burn out fast.

Meanwhile, contrast it. The overwhelming majority of government offices have up-to-date meeting rooms with well-furnished chairs and spotlessly clean floors—filled with a dozen or so workers at a time. Across town, schools have splintered chairs, makeshift partitions, and tarpaulin roofs. The unequal distribution is not only absurd. It is excruciating.

To remedy this, DepEd is targeting the construction of 15,000 additional classrooms by 2027 via public-private partnerships. It is, however, a small drop in a very large ocean given the existing backlog. It is argued by critics that infrastructure is a state function, not a job for contracting out. It demands legislation for complete 6% GDP support for education, a constitutional obligation that is only partially fulfilled.

Projects by non-government organizations like the Generation HOPE initiative—in partnership with brands like Penshoppe and SM—call for innovative solutions, funneling funds from customers towards construction in schoolrooms. While noble, they raise a question too: why should learning be dependent on charity when it is a fundamental right?

Construction is in itself ineffective. EDCOM 2 reports that only 847 classrooms were scheduled for construction

in 2022—stalled by delays, land, and contractor complications. Not even DPWH and DepEd can find common ground on a cost for a classroom. Students wait in the inter-

im. Classrooms in Quezon City's Bagong Silangan High School are doubled up, with up to 100 students passing through in rotation. The teachers juggle classes, time, noise, and heat like double-duty stage performers. The teacher in Canitoan Elementary in Cagayan de Oro spans a number of grade levels in a room, making it all up as she goes along so that the day would proceed smoothly.

Teachers, often unsung heroes, still show up. Some arrive before dawn, make room for heat and hour-fluctuating classes, and get it done because someone has to. Their perseverance is a testament, though often implicit, to a broader responsibility—to get in front of students where they are, no matter tough the environment.

Others propose using hybrid learning as a solution. But that only works if students have access to reliable internet and devices, which is never true in those same places where they are worst-hit by shortages. It is not very

innovative for a Grade 4 pupil in a remote barangay to be made to study in front of a computer when his unfinished classroom is still available. That is evasion.

The difference increases when they look at well-finished office interiors in government buildings while classes remain unfinished. Motion detectors in empty lounges, but children have plastic chairs. It is not a case of jealousy—it is equity.

It is high time for a more down-to-earth approach to infrastructure. If meeting rooms can be fitted out for ergonomic chairs, high time for a real-walled classroom, ventilation, and tables. Children should not have to take a test sweating, standing, or balancing a notebook on a knee.

We are not asking for marble campuses. Just rooms that facilitate real learning. Space enough for students to be in, enough air for them to breathe, enough dignity for them to grow. If we actually value free and good education, our schools should be a reflection of that promise, not only on paper but in walls. Because that pupil learning under a banana tree? That is not just a picture of poverty, it is a reflection of our priorities. Unless we are serious about our future, it is well past time for us to get started on repairing it, classroom by classroom—with all due speed, integrity, and unsparing dedication.

Rethinking the EDSA repair strategy

Segmented reconstruction is a road repair method where highways or major roads are rehabilitated in phases, one section at a time. This approach is widely used in urban planning to balance infrastructure development with the need to maintain smooth traffic flow.

Segmented reconstruction is a progressive and practical road repair strategy. However, its benefits can only be realized if implemented with clear planning, common sense, and a deep understanding of traffic dynamics.

Instead of shutting down an entire stretch of road, only specific segments are closed for repairs while the remaining lanes remain open to motorists. This technique minimizes congestion, reduces the economic cost of traffic disruptions, and ensures continuous mobility, especially in heavily utilized roads like EDSA in Metro Manila.

In the recent EDSA rehabilitation project, the Metropolitan Manila Development Authority (MMDA) had proposed to implement segmented reconstruction, beginning with the southbound lanes before progressing to the northbound side. This step-by-step strategy was expected to always keep at least part of the highway open, thereby allowing traffic to continue flowing—albeit with some delays.

However, contrary to the logic behind segmented reconstruction, the MMDA also proposed implementing an "odd-even" vehicular scheme to reduce the volume of vehicles during the project period. This proposed scheme raised many eyebrows.

If the segmented reconstruction method inherently aims to prevent full road closures and maintain manageable traffic flow, why would there be a need to impose an additional vehicle restriction scheme?

The odd-even system, which only allows vehicles with license plates ending in odd or even numbers to travel on certain days, has historically caused confusion and inconvenience for commuters. Its implementation would have added another layer of difficulty to an already congested road network.

Another glaring oversight was the lack of a robust nighttime repair plan. Conducting construction activities at night—a common practice in many developed cities—significantly reduces daytime disruptions. It allows for faster work with minimal impact on traffic.

Cities like Tokyo and New York routinely use nighttime hours for infrastructure maintenance. The absence of such a strategy in the MMDA's original plan suggested a lack of foresight and adaptability in urban traffic management.

Fortunately, President Ferdinand Marcos Jr. intervened and halted the plan, recognizing the potential chaos it could cause. His decision gave MMDA a chance to reassess and improve their strategy, giving segmented reconstruction a fair opportunity to work as intended.

The President's action reflects a more practical understanding of public inconvenience and urban efficiency. It also sends a clear message that infrastructure development must always consider the lived experiences of ordinary commuters.

Now, with a chance to implement segmented reconstruction properly, the MMDA must refine their approach. This includes better traffic engineering, consultation with urban planners, and clear communication with the public. Repair schedules should consider off-peak hours, and real-time updates should be made available to commuters. Moreover, inter-agency coordination—particularly with traffic enforcers and local governments—is critical to the method's success.

In conclusion, segmented reconstruction is a progressive and practical road repair strategy. However, its benefits can only be realized if implemented with clear planning, common sense, and a deep understanding of traffic dynamics. The recent EDSA situation is a learning opportunity for Metro Manila's policymakers—an opportunity to modernize roadworks while prioritizing public convenience.

ni Mayor Arlene bilang punonglung-sod, matapos siyang mahalal muli nang walang kalaban. Sa kanyang talumpati, taos-puso niyang pinasalamatan ang 162,000 na mga botante ng lungsod na muling nagtiwala sa kanyang pamumuno.

“Running unopposed is not a personal triumph; it is our collective declaration na walang makapipigil sa tuloy-tuloy na pag-unlad ng Santa Rosa bilang isang makabagong lungsod na nagbibigay ng makataong serbisyo sa mamamayan,” ani Mayor Arlene.

In her inaugural address, Governor Aragones outlined the core priorities of her administration, placing strong emphasis on healthcare access, digital innovation, tourism development, and transparent governance.

At the heart of her governance agenda is the flagship health program “Akay ni Sol,” which aims to provide inclusive medical assistance across the province.

One of the first components to be launched is the “Akay ni Sol Mobile Botika,” which will distribute free maintenance medicines to senior citizens, persons with disabilities, and individuals with chronic illnesses.

“This is not just a program, this is a promise—a promise from a government that cares and has a heart,” Aragones declared in her speech, drawing loud applause from the audience. “No

Lagunense will be left behind when it comes to healthcare.”

She further announced that beginning in September 2025, construction will commence for permanent “Akay ni Sol Botika” centers across all six cities and 24 municipalities of Laguna.

These facilities are expected to be completed by November 2025 and will serve as community access points for free medicines and medical consultations.

“Even if you live in the mountains or the most remote areas—services must reach you,” Aragones emphasized. “Healthcare should not be a privilege; it must be a right.”

In addition to healthcare, the governor introduced a new digital platform called the “Akay ni Sol App,” which will allow Lagunenses to conveniently book and track medicine requests,

medical appointments, and other health services online.

“Technology must serve the people, especially in times of illness and need,” she said. “This app will be your companion in making sure your health is protected, wherever you are in the province.”

Governor Aragones also discussed plans to strengthen tourism through a grassroots media initiative that promotes citizen journalism.

“We want the stories of our towns to be told by the people themselves—our students, our workers, our elders. The voice of the people, for the people,” she explained.

To promote local pride and strengthen regional identity, symbolic tourism arches will also be constructed at key entry points in Laguna.

These landmarks will feature

elements of local history and culture, showcasing what makes each town or city unique.

Finally, the governor reiterated her strong stand on good governance. “Transparency, accountability, and integrity will be the foundation of this administration,” Aragones stated.

“We are here not to be served, but to serve. Public service is not an honor, but a responsibility.”

The oath-taking ceremony was attended by local officials, government employees, civic organizations, and community leaders, marking a new chapter in Laguna’s path forward under renewed leadership.

“This is a fresh beginning,” Aragones concluded. “With unity, compassion, and dedication, we will make Laguna healthier, stronger, and prouder than ever before.”


